**ORDER OF REEMPLOYMENT ASSISTANCE APPEALS COMMISSION**

---

This case comes before the Commission for disposition of an appeal of the decision of a reemployment assistance appeals referee pursuant to Section 443.151(4)(c), Florida Statutes. The referee's decision stated that a request for review should specify any and all allegations of error with respect to the referee's decision, and that allegations of error not specifically set forth in the request for review may be considered waived.

Upon appeal of an examiner's determination, a referee schedules a hearing. Parties are advised prior to the hearing that the hearing is their only opportunity to present all of their evidence in support of their case. The appeals referee has the responsibility to develop the hearing record, weigh the evidence, resolve conflicts in the evidence, and render a decision supported by competent and substantial evidence. Section 443.151(4)(b)5., Florida Statutes, provides that any part of the evidence may be received in written form, and all testimony of parties and witnesses shall be made under oath. Irrelevant, immaterial, or unduly repetitious evidence shall be excluded, but all other evidence of a type commonly relied upon by reasonably prudent persons in the conduct of their affairs is admissible, whether or not such evidence would be admissible in a trial in state court. Hearsay evidence may be used for the purpose of supplementing or explaining other evidence, or to support a finding if it would be admissible over objection in civil actions. Notwithstanding Section 120.57(1)(c), Florida Statutes, hearsay evidence may support a finding of fact if the party against whom it is offered has a reasonable opportunity to review such evidence prior to the hearing and the appeals referee or special deputy determines, after considering all relevant facts and circumstances, that the evidence is trustworthy and probative and that the interests of justice are best served by its admission into evidence.

By law, the Commission's review is limited to those matters that were presented to the referee and are contained in the official record. A decision of an appeals referee cannot be overturned by the Commission if the referee's material findings are supported by competent and substantial evidence and the decision comports with the legal standards established by the Florida Legislature. The Commission cannot reweigh the evidence or consider additional evidence that a party could have reasonably been expected to present to the referee during the hearing. Additionally, it is the responsibility of the appeals referee to judge the credibility of the witnesses and to resolve conflicts in evidence, including testimonial evidence. Absent extraordinary circumstances, the Commission cannot substitute its judgment and overturn a referee's conflict resolution.

Having considered all arguments raised on appeal and having reviewed the hearing record, the Commission concludes no legal basis exists to reopen or supplement the record by the acceptance of any additional evidence sent to the Commission or to remand the case for further proceedings. The Commission concludes the record adequately supports the referee's material findings.

On review, we affirm the referee's decision on slightly different grounds. The referee concluded that the employer failed to prove with competent evidence two of the three incidents involved in the termination pursuant to the employer's progressive discipline policy. Thus, the referee determined that the policy was not "fairly enforced" in this instance. The Commission has previously held that for a discharge under a progressive discipline policy that mandates termination after a certain number of offenses, the employer must prove each of the relevant instances as part of its prima facie case to establish a "violation" of its policy pursuant to Section 443.036(30)(e), Florida Statutes. See R.A.A.C. Order No. 13-04616 (August 5, 2013).<sup>1</sup> Accordingly, it was not necessary for the referee to address the fair enforcement defense due to the employer's failure to prove the violations under the policy.

**DECISION OF APPEALS REFEREE**

**Issues Involved:**

SEPARATION: Whether the claimant was discharged for misconduct connected with work or voluntarily left work without good cause as defined in the statute, pursuant to Sections 443.101(1), (9), (10), (11); 443.036(30), Florida Statutes; Rule 73B-11.020, Florida Administrative Code.

**Findings of Fact:** The claimant was a front desk clerk at a hotel until May 2013. The claimant was responsible for making drops in the safe. The claimant was working with a trainee who signed documentation that she witness the drop made on May 24, 2013. The claimant asked that employee to make the drop for her and went to the desk to help a customer. The envelope was reportedly found on the front desk later that day. The claimant was warned before this incident about a late arrival on April 2, 2013. The claimant was late due to the distance she had to travel to work and the availability of childcare early in the morning. Subsequent tardiness was excused after the claimant explained why she was late. The claimant was also reprimanded when she was reported to have refused to take a delivery. The claimant was discharged for exceeding the number of write ups allowed in a year.

**Conclusions of Law:** As of June 27, 2011, the Reemployment Assistance Law of Florida defines misconduct connected with work as, but is not limited to, the following, which may not be construed in pari materia with each other:

- (a) Conduct demonstrating conscious disregard of an employer's interests and found to be a deliberate violation or disregard of the reasonable standards of behavior which the employer expects of his or her employee.
- (b) Carelessness or negligence to a degree or recurrence that manifests culpability, or wrongful intent, or shows an intentional and substantial disregard of the employer's interest or of the employee's duties and obligations to his or her employer.
- (c) Chronic absenteeism or tardiness in deliberate violation of a known policy of the employer or one or more unapproved absences following a written reprimand or warning relating to more than one unapproved absence.
- (d) A willful and deliberate violation of a standard or regulation of this state by an employee of an employer licensed or certified by this state, which violation would cause the employer to be sanctioned or have its license or certification suspended by this state.
- (e) A violation of an employer's rule, unless the claimant can demonstrate that:
  - 1. He or she did not know, and could not reasonably know, of the rules requirements;
  - 2. The rule is not lawful or not reasonably related to the job environment and performance; or
  - 3. The rule is not fairly or consistently enforced.

The record reflects that the claimant was discharged for exceeding the number of write ups allowed under a policy. The claimant was shown to have earned the last of these write ups for a drop which was allegedly found on the desk. The employer's evidence to show that the drop was not made and that the cash envelope was later found on the front desk consisted of hearsay testimony. Hearsay evidence may be used for the purpose of supplementing or explaining other evidence, or to support a finding if it would be admissible over objection in civil actions. Notwithstanding s. 120.57(1)(c), hearsay evidence may support a finding of fact if:


1. The party against whom it is offered has a reasonable opportunity to review such evidence prior to the hearing; and
2. The appeals referee or special deputy determines, after considering all relevant facts and circumstances, that the evidence is trustworthy and probative and that the interests of justice are best served by its admission into evidence. Hearsay testimony cannot meet these conditions and is not sufficient as evidence to prove the matter asserted. One of the other reprimands offered shows that the claimant was concluded to have refused to take delivery of a package for a guest slated to check in. The documents provided to substantiate that offence do not show that she was the responsible actor. The claimant's testimony clearly shows that she did not have any involvement with that package. As two of the reprimands which cause the claimant to violate the policy was not shown to have been based on infractions which can be proved, the policy regarding the number of infractions allowed cannot be viewed as fairly enforced. The claimant was not shown to have acted with a deliberate disregard for the employer or her responsibilities to the employer. Misconduct was not shown. The claimant is qualified and the employer shall be charged.

**Decision:** The determination dated August 14, 2013, is REVERSED.

If this decision disqualifies and/or holds the claimant ineligible for benefits already received, the claimant will be required to repay those benefits. The specific amount of any overpayment will be calculated by the department and set forth in a separate overpayment determination, unless specified in this decision. However, the time to request review of this decision is as shown above and is not stopped, delayed or extended by any other determination, decision or order.

A party requesting review should specify any and all allegations of error with respect to the referee's decision, and provide factual and/or legal support for these challenges. Allegations of error not specifically set forth in the request for review may be considered waived.
